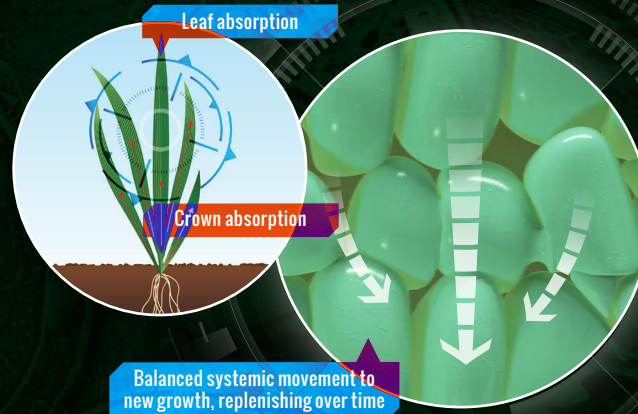

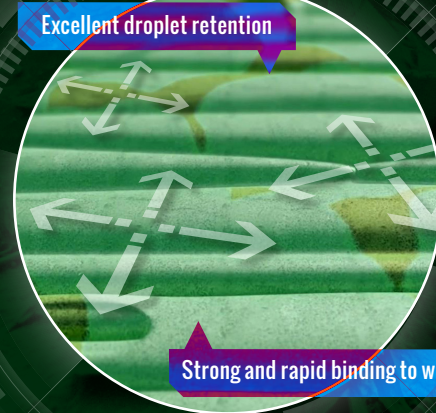

Active concentrated at the leaf tip is then removed with mowing, diluting the leaf protection available.

ASCERNITY moves from stems, crowns and axils for protection of new growth and doesn't accumulate at the leaf tip of existing leaves. These balanced movement properties together with outstanding stability in the plant means more complete and sustained protection from disease.



The advanced ASCERNITY formulation delivers excellent product retention when applied and has rapid initial uptake into the leaf.



OPTIMUM USE PERIOD

Used as a strategic part of an integrated Turf Management plan, ASCERNITY can assure a sustainable long-term future for effective turf disease control.
